1. Interpretation

"the Applicant" means the individual who signs this Contract and agrees to be bound by its terms and includes a guardian of that individual if the individual is under 18 years of age.

2. Acceptance

the Applicant, hereby agree to be bound by the terms of this Contract with GPS Speed Team Challenge and the persons named and described in Schedule 1, hereinafter jointly and severally referred to as "the providers". The providers agree to permit me to participate in the GPS Speed Team Challenge under the following conditions:

(a) Fees

The Applicant will not pay any fees to participate.

(b) Medical Conditions

The Applicant warrants that he or she has not at any time suffered any blackout, seizure, convulsion, fainting or dizzy spells and is not presently receiving treatment for any illness, disorder or injury, which would render it unsafe for the Applicant to take part in Windsurfing at Speed.

Waiver and Indemnity

In all other cases and except where inconsistent with the above, the Applicant for him/herself, his/her executors, administrators, dependents and other personal representatives, hereby absolves and indemnifies the providers and all their servants, agents, employees and other persons under the providers control (the "indemnified") from all liability howsoever arising for injury or damage (including but not limited to the Applicants' person, whether fatal or otherwise, property and personal belongings) however caused including by the negligence of the indemnified, arising out of or participating in The GPS Speed team Challenge or in anyway caused by, or arising out of, any activity carried on by the indemnified.

I, the Applicant, have been advised and understand that the practice of Windsurfing at Speed is potentially dangerous.

(f) Windsurfing at Speed is done at Applicant's own Risk

Any person Windsurfing at speed, or in activities connected with Windsurfing at speed, or participating in any activity carried on by this The GPS Speed Team Challenge, are only allowed to do so on the distinct understanding that they do so entirely at their own risk.

(g) Agreement to abide by the GPS Team Challenge Rules

(h) I, the Applicant, agree that I will abide by the GPS Team Challenge Rules

(i) Acceptance

Performance of the provider's obligations under the contract may be effected by any one or more of the providers either jointly or severally.

(j) Governing Law

Any agreement entered into pursuant to this acceptance is to be governed by the laws of the State of Western Australia and the Courts of Western Australia shall have exclusive jurisdiction to entertain any action in respect of any such agreement.
